BUDGET ORDINANCE FOR FISCAL YEAR 2023-2024

BE IT ORDAINED and established by the Board of Commissioners of the Town of Ranlo, North Carolina on this the 8th day of June 2023 as follows:

Section I. The following amounts are hereby appropriated in the General Fund for the operation of its activities for the fiscal year beginning July 1, 2023 and ending June 30, 2024 in accordance with the chart of accounts established for the Town:

Section VIII: The following amounts are hereby appropriated in the Utility Fund for the operation of water and sewer utilities for FY 2023-2024:

Admin and Engineering:	\$193,918.00
Non-Departmental:	\$17,500.00
Sewer:	\$765,126.00
Water:	\$762,241.00
Addition to Fund Balance:	\$58,015.00

Total \$1,796,800.00

Section IX: There is hereby levied a tax at the rate of 45 cents (.45) per one hundred dollars of valuation of property as listed for the purpose of raising revenue listed as “Current Year’s Property Taxes” in the General Fund in Section Two of this ordinance. Per North Carolina General Statute 159-11(e), the Town’s revenue neutral property tax after the recent revaluation equates to \$0.3383 per one hundred dollars of valuation.

Section X: A registration tag tax fee of \$5.00 per vehicle is hereby levied.

Section XI: The town manager/budget officer is hereby authorized to transfer appropriations within a department without limitations and without a report being required in the following manners:

- (A) Amounts may be transferred between line-item expenditures within a department without limitations and without a report being required.
- (B) Amounts not exceeding \$5,000 may be transferred between departments of the same fund.
- (C) Contributions may be transferred between funds when needed, but the transfers may not exceed the contribution amounts contained in this ordinance.

Section XII: The town manager/budget officer is hereby authorized to execute the necessary agreements within funds included in the budget ordinance for the following purposes:

- (A) Purchase of apparatus, supplies & materials where formal bids are not required by law;
- (B) Lease of normal and routine business equipment;

- (C) Construction or repair work where formal bids are not required by law;
- (D) Consultant, professional or maintenance service agreements prescribed by law;
- (E) Agreements for acceptance of state & federal grant funds; and
- (F) Grant agreements with public & non-profit agencies.

Section XII: Grant funding and grant project ordinances not completed in the prior fiscal year may be carried over and continue under the direction and approval of the Town Manager.

Section XIII: Copies of this budget ordinance shall be furnished to the Finance Department to be kept on file for the disbursement of town funds and to the Town Clerk for permanent record keeping.
