IX. Adoption of May 8th, 2025, Regular Meeting Minutes of the Board

XII. Public Hearing for adoption of the Fiscal Year 2025-2056 Budget Ordinance

Mayor Pro-Tem Moore made a motion to open Public Hearing. Commissioner Laws seconded the motion. Motion Passed unanimously. There were no comments from the public. Commissioner Laws motion to close Public Hearing. Mayor Pro-Tem Moore seconded the motion. Motion passed unanimously.

New Business:

XIII. Consideration and Approval of the FY2025-2026 Budget

The Town Manager presented the Budget to the Board and requested that the Board approve the prepared and balanced budget for FY25/26. Mayor Pro-Tem Moore made the motion to approve budget. Commissioner Morton seconded the motion. Motion passed unanimously.

XIV. Presentation of the Monthly Financial Expense Report

The Town Manager went over the new Monthly Financial Expense Report noting that this month's report goes over the monthly and year-to-date spending for the Town. The manager highlighted Page 1 of the report gives an overall look at all the Town's accounts and associated interests accrued in each of the accounts. Page two of the document

shows each department account within the general operating budget and the percentage each account has expended compared to how far along the town is throughout the fiscal year.

XV. Consideration of Budget Amendments 2425.26

Mayor Pro-Tem Moore Motion to approve budget amendment 2425.26. Commissioner Locklear seconded the motion. The Motion passed unanimously 5-0 vote.

XVI. Consideration of entering into Annual Audit Contract with Eddie Carrick

The Town Manager stated it was time to sign the annual audit contract and request we use Eddie Carrick who has done the passed few years of Audits for the Town of Ranlo. Mayor Pro-Tem Moore made the motion to accept audit contact. Commissioner Laws seconded the motion. Motion passed unanimously.

XVII. Resolution of the South Fork Passage Support

The Town Manager advised of the South Fork Passe Trail that was requested by neighboring communities for a Resolution of Support. Commissioner Laws made the motion. Mayor Pro-Tem Seconded the motion. The Motion Passed Unanimously.

XVIII. Resolution of intent to apply for Lead and Copper Funding

The Town Manager advised that Ranlo was one of the First Municipalities to get their Lead and Copper Survey Done. There are no Lead Lines in Ranlo. This Resolution is just stating that Ranlo intends to apply for Lead and Copper funding in the Future. Mayor Pro-Tem Moore Motion to accept the Resolution. Commissioner Laws seconded the motion. The motion passed unanimously.

XIX. Resolution to be included in the Regional Hazard Mitigation Plan

The Town Manager advised this makes use eligible for funding through this Regional Hazard Mitigation plan if something like Helen was to happen again. Commissioner Laws made the motion to accept Resolution. Mayor Pro-Tem Moore seconded the motion. The motion passed unanimously.

XX. Adoption of Town Personnel Policy Manual FY25-26

The Town Manager advised this policy was what the HR director and himself have been working on the pass few months. He notated a few key changes such as Aggrievement leave not having to be consecutive days as well as updating Maternity Leave. Mayor Pro-Tem Moore made the motion to Adopt new Town Personnel Policy. Commissioner Laws seconded the motion. The motion passed unanimously.

XXI. No 18-Wheelers Behind Mills Discussion

The Town Manager advised that Commissioner Morton had approached him and wanted to discuss with the rest of the Commissioners 18 Wheelers Behind the Mills. Commissioner Morton goes on to state that the 18 wheelers are causing a lot of damage to residents' properties. The Board advised for the Town Attorney and Town Manager to come up with a possible Solution. No Action taken at this time.

XXII. Discussion to Amend the 2025 Calendar of Events

The Town Manager advised that after discussion with a commissioner he would like to request that the Town for go the July Celebration event and instead have Fireworks at the End on the Milltown Nights on July 18th. Mayor Pro-Tem Moore Made the motion to Cancel the July Celebration on the 26th and have Fireworks on the 18th. Commissioner Laws seconded the motion. The motion Passed Unanimously.

XXIII. Town Manager Overview of Milltown Night Themes

The Town Manager went over the Themes for each upcoming Milltown Nights. June is for the kids/school out. July is going to be a USA Car/Motorcycle Show with country music. August will be a shagging contest. Special Thanks to Commissioner Locklear with bringing Milltown Nights back to life.

XXIV. Award the Demolition Bid of Old Town Hall

The Town Manager advised after the Bidding Process he proposed for the Town to Award the Demolition Bid for the Old Town Hall to Lewis Site Development. Mayor Pro-Tem Moore made the motion to Award the Demolition to Lewis Site Development. Commissioner Locklear Seconded the motion. The motion passed unanimously.
