Page two of the document shows each department account within the general operating budget and the percentage each account has expended compared to how far along the town is throughout the fiscal year.

Will be an advertisement for 30 days to see if any Muralist is interested in doing the mural. Mayor Pro-Tem Moore made a motion to move forward with the RFQ. Commissioner Conner seconded the motion.
